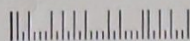

Motor Carrier Safety & Insurance Certification - If registered for a weight in excess of 10,000 pounds operating interstate, I certify knowledge of applicable Federal Motor Carrier safety regulations, hazardous materials regulations, and applicable State laws and regulations, and declare all operations will be conducted in compliance with such requirements. I also certify under penalty of law that the described vehicle is and will be continuously insured as prescribed under the applicable state and federal rules listed below:

- State - IDAPA 39.02.80, Motor Carrier Financial Responsibility
- Federal - 49 CFR Part 387, Minimum Levels of Financial Responsibility for Motor Carriers

Display of Credentials

The vehicle registration may be carried electronically as per Section 49-427, Idaho Code. It must be in possession of the driver or carried in the vehicle, and is subject to inspection by any peace officer.

The license plate must at all times be securely fastened to the vehicle to which it is assigned to prevent the plate from swinging, be at a height not less than twelve (12) inches from the ground, measuring from the bottom of the plate, be in a place and position to be clearly visible at the rear of the trailer, and shall be maintained free from foreign materials and in a condition to be clearly legible, as per Section 49-428, Idaho Code.

A plate validation decal is not issued as per Section 49-428, Idaho Code.
