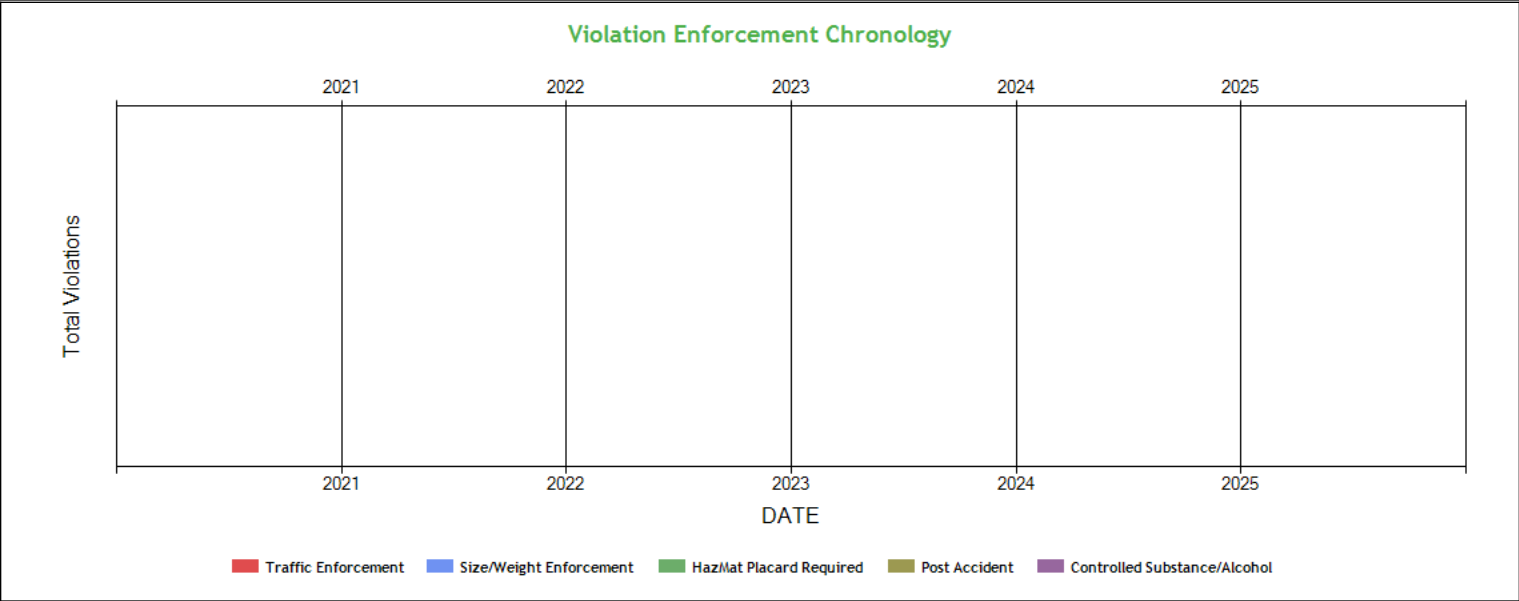

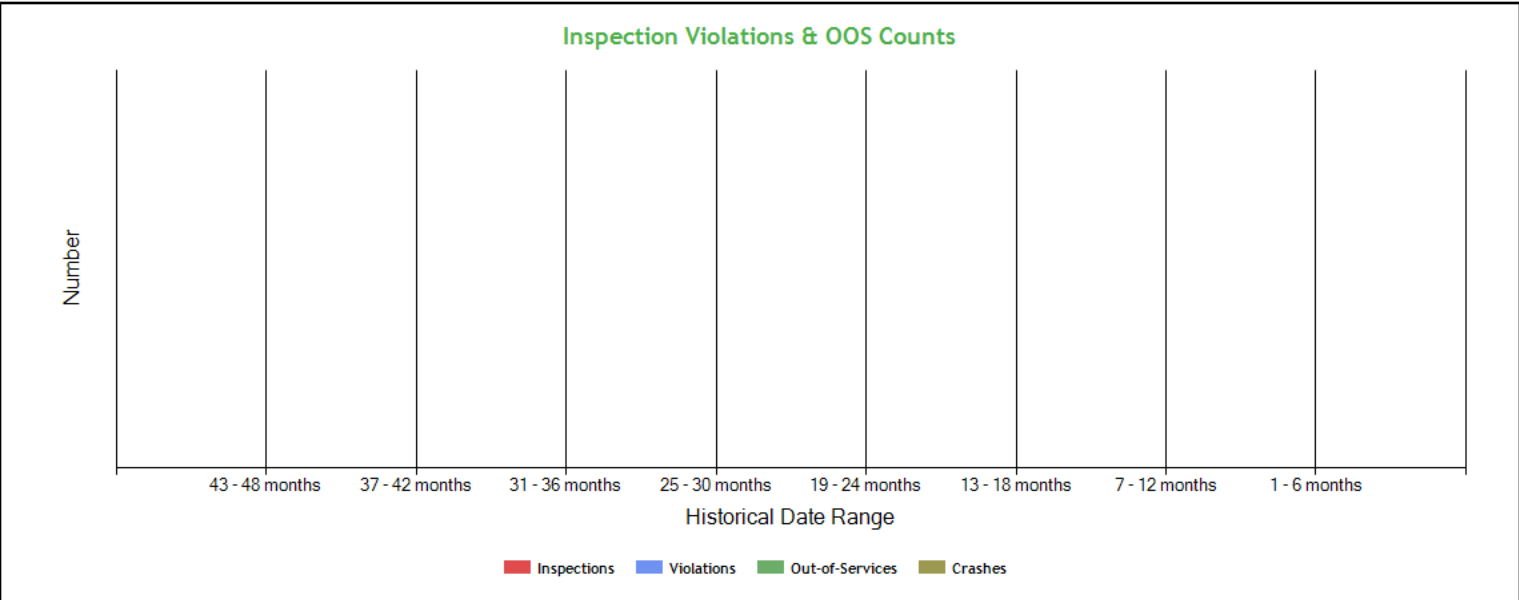
Violation Enforcement Chronology - Chart **ToC**

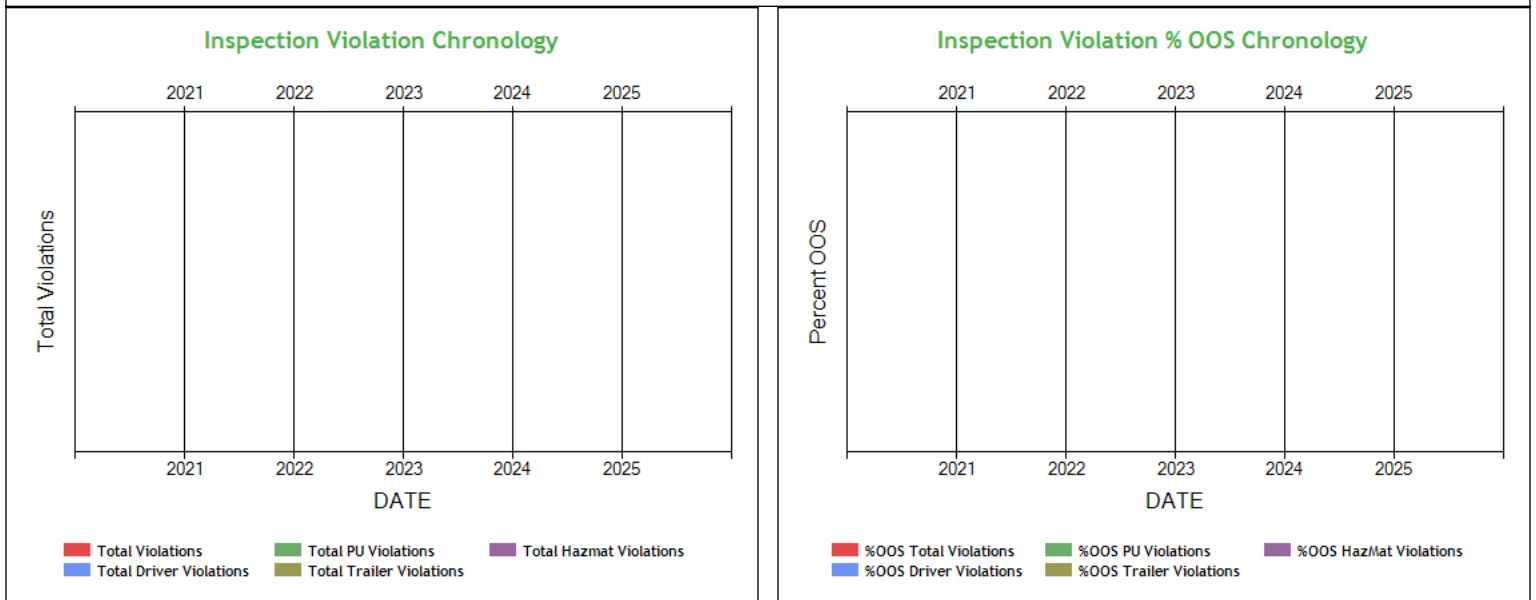

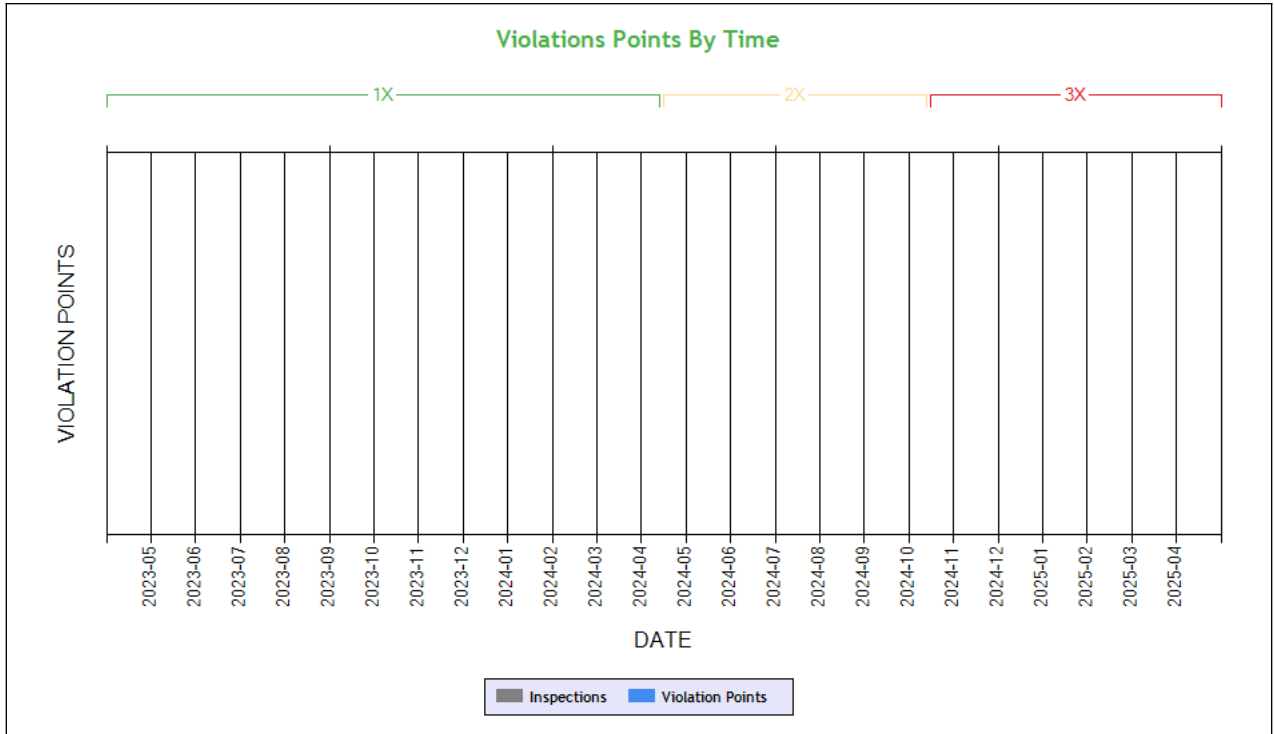

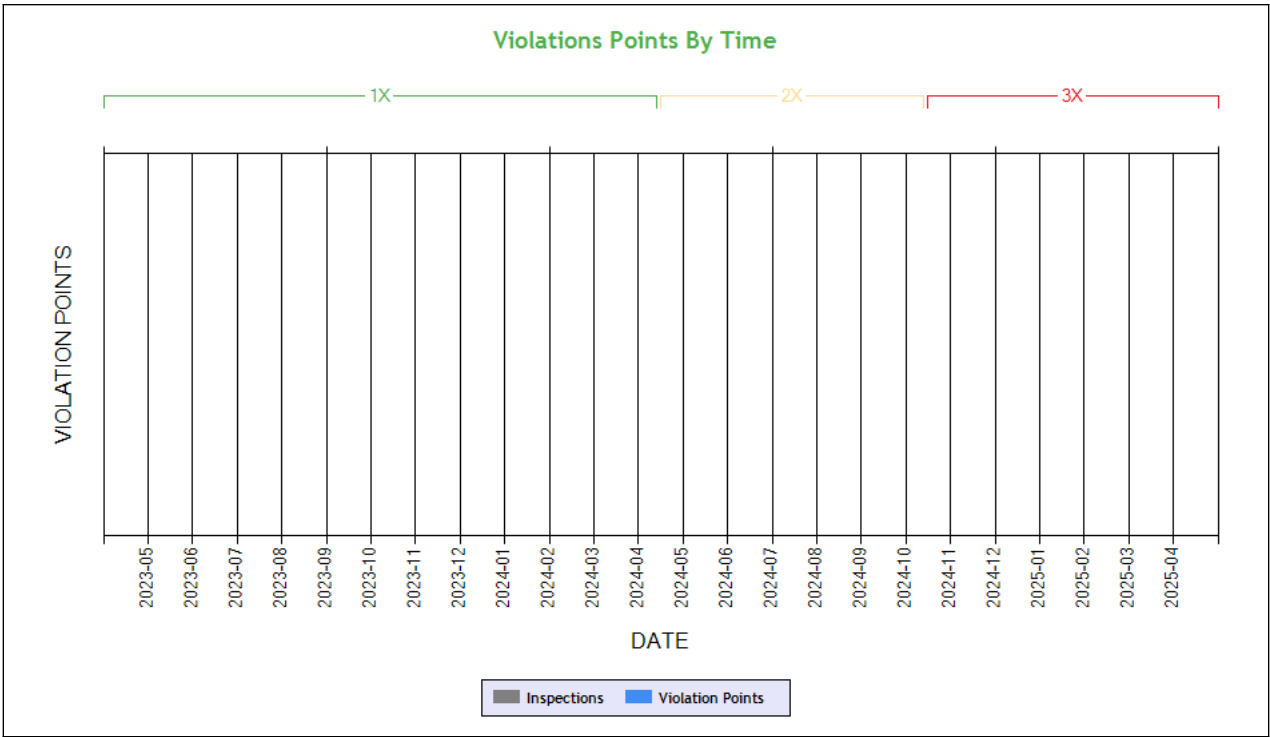
