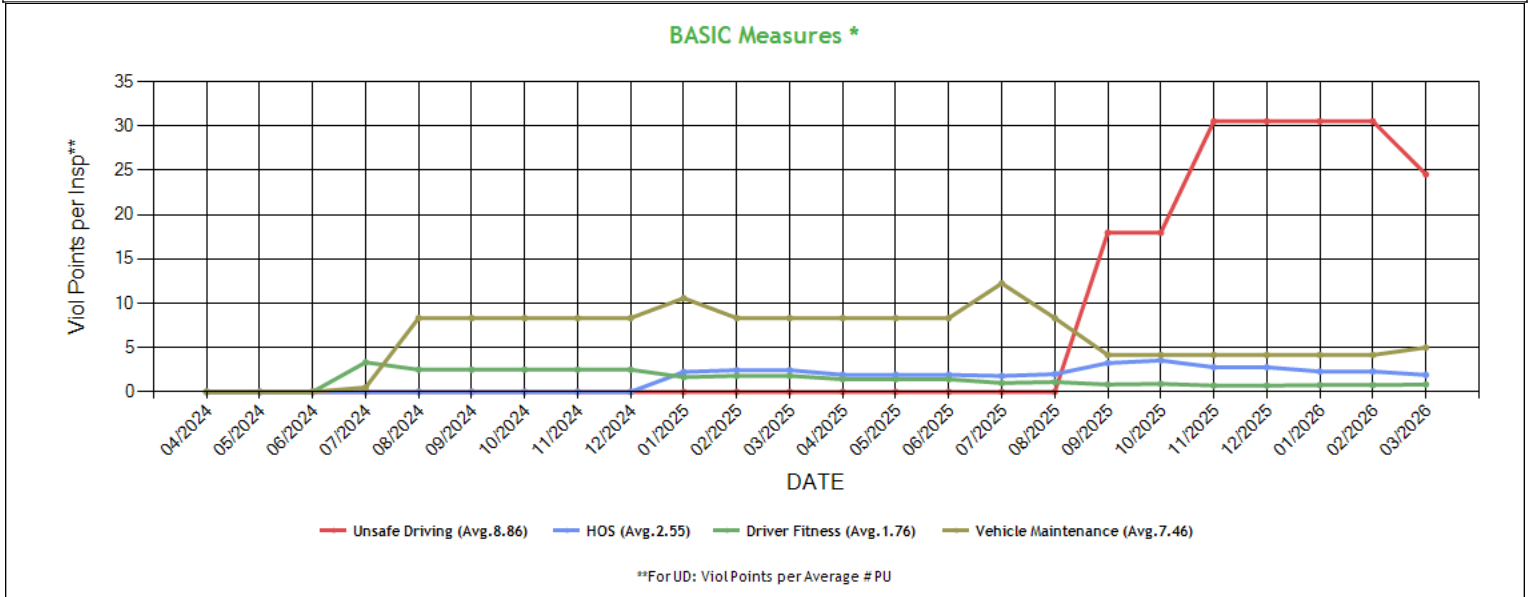

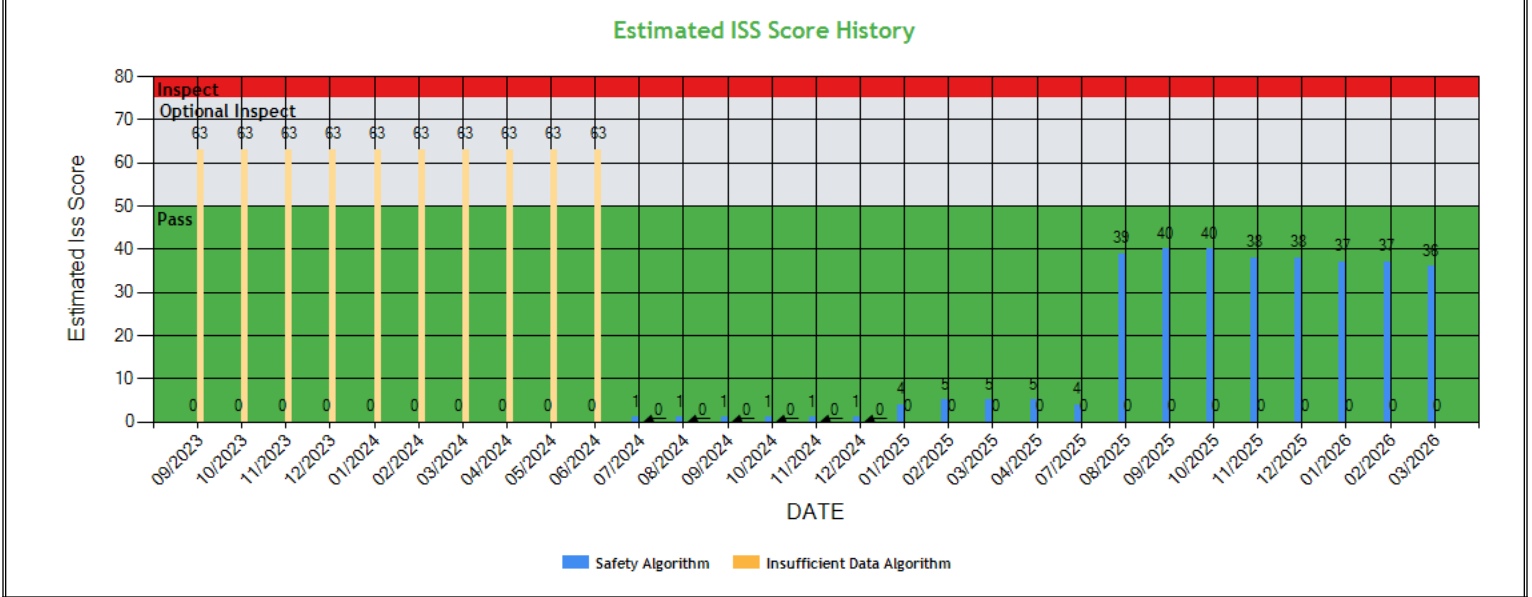

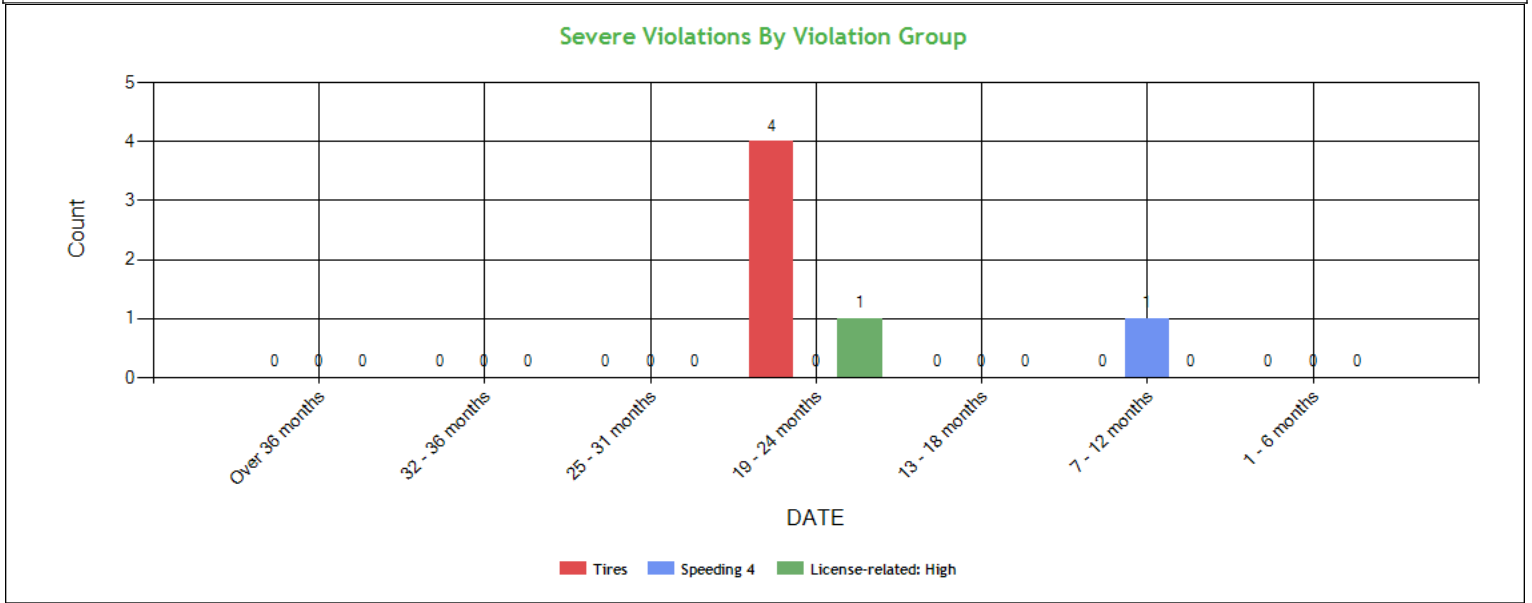

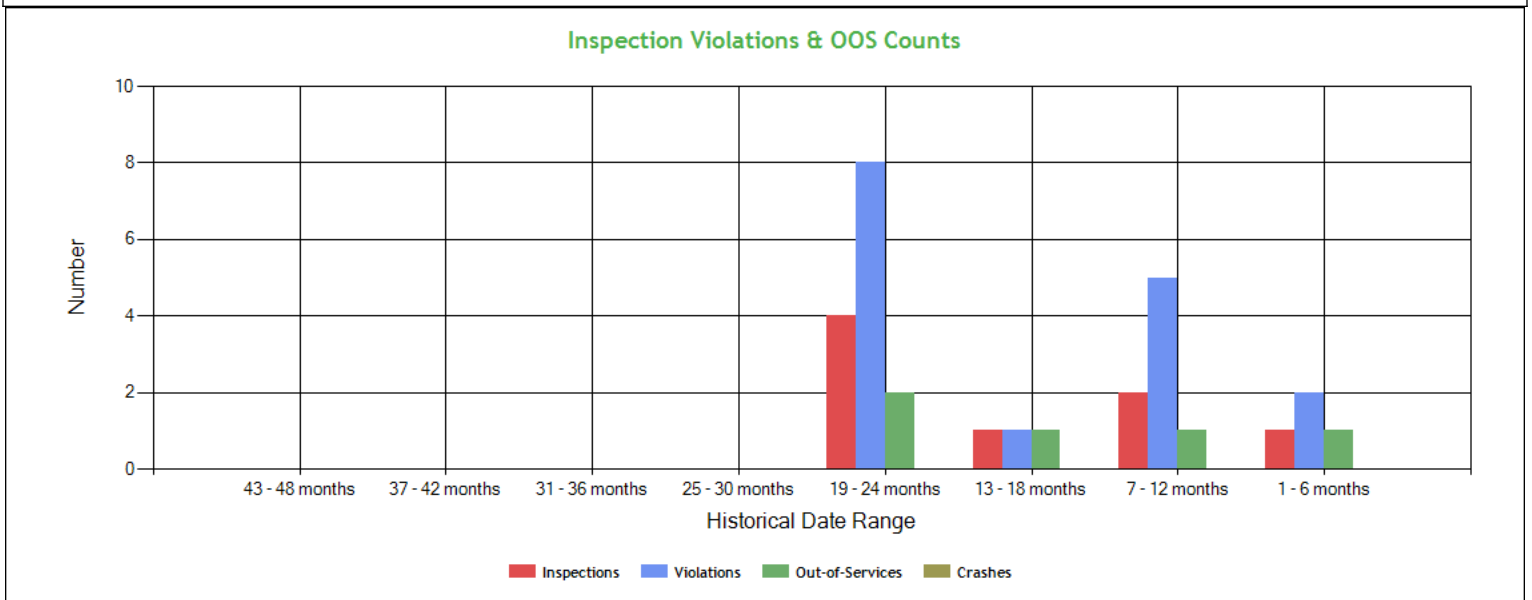
Violation Enforcement Chronology - Chart ToC

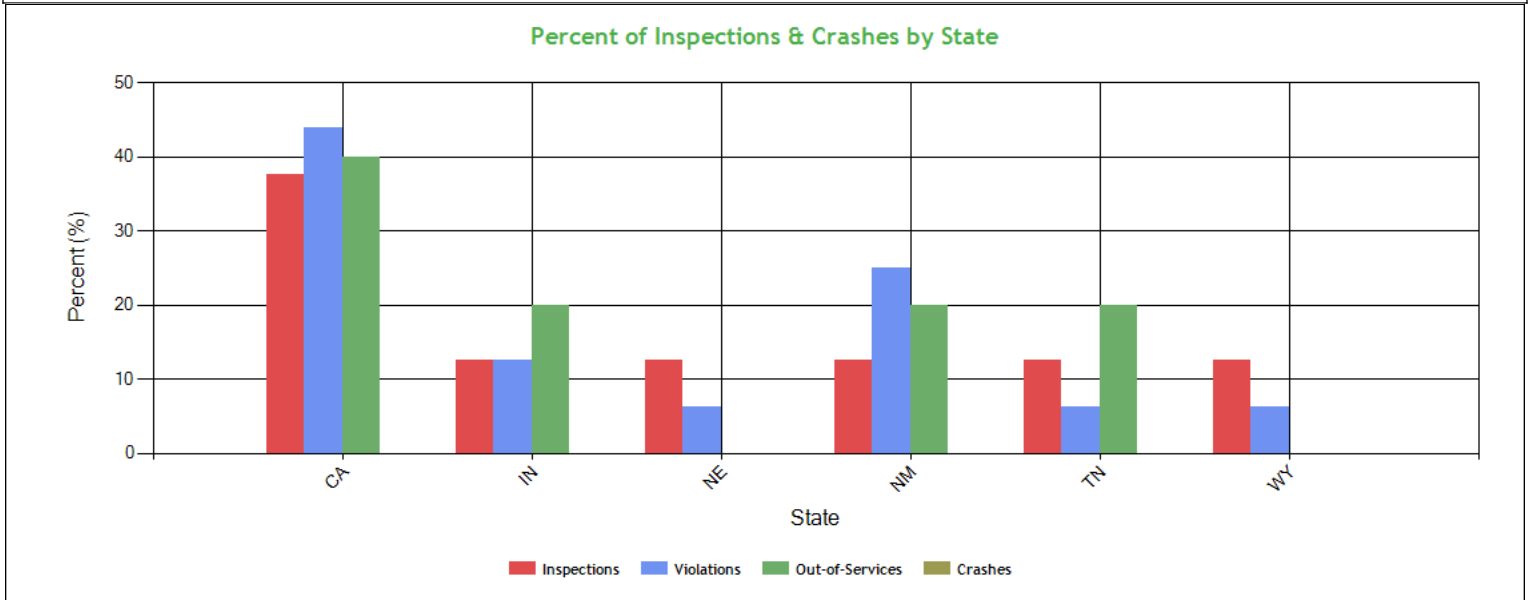
