## NOTICE OF CANCELLATION - INSURANCE PREMIUM FINANCE AGREEMENT

### TO THE INSURANCE COMPANY:

On auditable policies, the gross pro rata return is requested. Subsequent audit results are to be reconciled between the insured and the insurance company.

This policy can be reinstated only by a specific written request by AFCO which does not represent or warrant that the policy will be reinstated. A request for reinstatement will only be considered upon receipt of \$3,788.78 or the total remaining balance due stated above and only the insurance company can reinstate.

**IMPORTANT NOTICE TO INSURED:** If the purpose of this loan was financing of automobile liability insurance, then it is your statutory duty to replace such insurance on or before the date of cancellation, if the motor vehicle is to continue being licensed in this state.
