EQUIPMENT INSURANCE ADDENDUM B

This Equipment Insurance Addendum B ("Addendum") is entered into this <u>6th</u> day of <u>February</u>, <u>2025</u>, and is hereby made a part of and incorporated within the Broker - Carrier Agreement or Dray Carrier Agreement ("Agreement") entered into by and between WERNER ENTERPRISES, INC., a Nebraska corporation, with its place of business at 14507 Frontier Road, Omaha, Nebraska 68138 ("Broker"), and <u>MAAN TRANSPORT LOGISTICTS INC</u>, with its place of business at <u>7283 N RIVERSIDE DR, FRESNO, CA, 93722</u> ("Carrier").

WHEREAS, Broker may, from time to time, permit Carrier to transport Broker owned or controlled trailers, containers, carriage conveyances (including but not limited to chassis), and ocean containers or other equipment (hereinafter collectively referred to as "Trailers") pursuant to the terms of the Agreement for the express purpose of utilizing the services of Carrier to make delivery or pick up of Broker-controlled freight, or any other purpose whether or not authorized by Broker;

NOW, THEREFORE, in consideration of the mutual terms, conditions, and promises hereof, the parties agree as follows:

1. Insurance. In addition to the insurance required under Section 8 of the Agreement, Carrier shall procure and maintain, at the sole cost and expense of Carrier, the following liability insurance with a reputable and financially-responsible insurance carrier or carriers properly insuring Carrier against liability and claims; (a) general liability coverage for bodily injuries to persons (including injuries resulting in death) and property damage in a combined single limit of not less than \$1,000,000 per occurrence, (b) trailer interchange coverage for loss of or damage to the Trailer while in the custody, possession or control of Carrier in an amount not less than the full value of the Trailer, (c) auto liability coverage for bodily injuries to persons (including injuries resulting in death) and property damage in a combined single limit of not less than \$1,000,000 per occurrence, (d) cargo insurance for the protection of commodities being transported in an amount not less than \$100,000, (e) contractual liability insurance covering the indemnifications contained within this Addendum, and (f) any additional insurance as may be required by applicable laws, ordinances or governmental orders, rules and regulation. As Carrier bears all risk of loss or damage to Trailers entrusted to and being in the possession of Carrier for the purposes of the Agreement, Carrier shall procure and maintain insurance in respect of such liability including any involved extension or inclusion under its automobile liability insurance policy. All insurance policies required hereunder shall name Broker as an additional insured thereon. Carrier shall obtain evidence from each insurance carrier showing that Broker has been named an additional insured on the policies, that such insurance has been procured and is being properly maintained, that the premiums therefor are paid, and specifying the name of the insurance carrier, the policy number or numbers, and the expiration date or dates. In the event of cancellation or material modification of any policy, written notice of such cancellation or modification shall be given to Broker at least thirty (30) days prior to such cancellation or modification as to each policy.

1. <u>Term of Addendum</u>. This Addendum will commence on the day and year first above written and continue for a period of one (1) year. The Addendum will automatically be extended on the same terms and conditions at the end of the first year and any renewal periods thereof. Either party may cancel or terminate this Addendum on thirty (30) days' written notice to the other.

Except as set forth in this Addendum, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. In the event of a conflict between this Addendum and the Agreement, the terms of this Addendum will prevail.
