UNIT CAME IN OTR FOR POSSIBLE LEAK/NOT HOLDING SETPOINT. HOOKED UP GAUGES AND BEGAN RUNNING THE UNIT. FOUND THE UNIT FULL OF FREON AND COOLING AS IT SHOULD. NO SIGNS OF ANY LEAKS ON THE OUTSIDE OF THE UNIT. PULLED THE EVAP PANEL AND CHECKED THE REAR, DID NOT FIND ANY ISSUE IN THE REAR. BEGAN LOCKING AT TRAILER. TRAILER IS MISSING ALL FOUR OF THE FLOOR DRAIN KAZOOS. THE AIR CHUTE IS ALSO MISSING THE UNIT ADAPTOR AND CAUSING A BLOCK OF AIRFLOW. THE REAR OF THE CHUTE HAS ALSO BEEN REMOUNTED COMPLETELY FLAT. TRIED TO SPACE REAR OF THE AIR CHUTE. CUSTOMER SAID HE WOULD HANDLE THE FRONT UNIT ADAPTOR. RAN AND CHECKED UNIT OPS AGAIN. EVERYTHING OK AT THIS TIME. TIME.
